**Education/Financial Literacy** – Non-profits and schools with educational missions, especially those with an emphasis placed on at-risk/low-income youth:

- Vocational Training – helping people acquire the skills they need to (re)enter the workforce.
- Agricultural Literacy – programs and services that teach responsible agricultural management to adults and young adults
- Enrichment Activities – after-school programs (i.e., music, computers, athletics, tutoring) that enhance classroom curriculums
- Student Advancement – tutoring, mentoring, scholarships, and other support aimed at helping students succeed in school

**Families in Need** – Community-based programs which focus on providing essential services to children and their families:

- Food Resources
- Emergency Shelter
- Health Services

**Public Safety Initiatives** – Programs dedicated to making local communities safer for our youth, employees and customers:

- Child Safety
- Neighborhood Safety
- Partnerships with law enforcement initiatives
